### **Chapter Delegates:**

Bring the card with you to the HOD meeting at 1:30 pm on Friday, October 12, 2012. Please don't mail it.

We recommend that delegates read this report prior to attending the meeting and obtain any chapter input on issues provided. Upon arrival at the HOD meeting, proceed to the table reserved for your division and present your credentials card to your District Vice President seated there. Delegates may not vote without presenting valid credential cards.

After the meeting, we recommend that delegates file reports with their chapter secretaries as part of a permanent record of the House of Delegate Proceedings.

### **District Board Members and Past District Presidents:**

No Credential Card is required for your participation in the HOD. Please be seated at your respective locations as follows:

- District Vice Presidents: with your respective divisions
- Past FWD Presidents: with your chapters or wherever convenient.
- A quorum will be determined from the credential cards presented to the district secretary by the respective District Vice Presidents.

These procedures for seating delegates and establishing the quorum at the spring and fall meetings were approved previously by the FWD Board of Directors and incorporated into the FWD Statement of Policy and the FWD Convention Regulations. Your observance of these procedures will facilitate the conduct and enhance the integrity of the meeting

### Greetings to my brother Barbershoppers,

For those of you serving your second year, and maybe even your first year, as a chapter or district president or officer, I am sure you will agree with me when I say how fast the past 20 months have flown by. It is hard to believe that this will be my last greeting to you as Society President at your House of Delegates meeting. It seems like only yesterday when I wrote the first one for the spring of 2011. But it has been a busy time and it has been a wonderful opportunity for me to serve each of you as the Society Board deliberated policy, setting aims for the Society, and making decisions that could affect each one of you in the same way that we, also really just members of a local chapter, will be affected. But the good news is that I will have two more years to serve you and work under the guidance of our next Society President, Shannon Elswick of the Sunshine District. I know that we are in good hands for those years.

Looking back it is interesting to see what we have accomplished and what we have initiated. Clearly, one of the most important tasks of any Board of Directors is the selection, election, and support of the Chief Executive Officer of the organization. We have been doing that since the end of March 2011 when Ed Watson informed us that he would be retiring in July of 2011. It was an opportunity for us as policy makers to rethink where we wanted this great organization to go in the next decade and decide what type of professional leader we wanted to take us there. We were clear on that direction. We were unanimous on that direction. We also agreed that we would do whatever it took to get us to that person and not just be satisfied with settling for the best available person. It took two search efforts. It took receiving and reviewing nearly 90 professional resumes. It took two dozen telephone and face-to-face interviews. It took hundreds of hours of time from members on the two search committees who worked tirelessly to get us to the personality, experience, and leadership that we wanted. But we got there. And you have received your first House of Delegates message from that new Chief Executive Officer/Executive Director, Marty Monson.

We kicked off Operation Harold Hill at the beginning of 2012 after seven months of planning in 2011. The effort was to have a Society-wide focus on membership recruitment – new members and getting some of our former members to return. Nearly 60% of our chapters have signed up to participate in Operation Harold Hill. We knew we would not get them all. There are many small chapters, probably those that need the help the most, who just can't or won't sign up. There are many chapters who are doing very well with membership, thank you very much, even before Operation Harold Hill and don't want to use up our resources needlessly. There are probably some, believe it or not, who don't even know about the program. But while we have been addressing the implementation and results to date of Operation Harold Hill, we knew this was not a one and done program – a program that would end upon the arrival of a new calendar year. That is what happened to other membership programs in previous years. Will it change? Will it morph and look different in another year? Probably, but the effort will still be there. It has already changed during 2012 at the hands of the Society Membership Committee. It became clear that membership recruitment was not the only issue to be solved. It was clearly identified that members were 'walking out the back door' as quickly (and more quickly) than we could bring them in the front door. So the Membership Committee developed the "Supercharging Your Chapter" program to provide a plan to help local chapters improve the retention of their existing members. We spend such great efforts to recruit new members, then ignore them and wonder why they leave before their first of second year of membership is over. Why would we not spend half the effort on retaining them that we do on recruiting them? So I urge each of you to adopt "Supercharging" or at least some program that specifically identifies ways to retain membership. And contrary to popular belief, the data indicates that the vast majority of those that leave are not doing so due to age. Seventy-five percent of the guys who leave are doing it because of something we have done, or not done, at our local chapters. Let's figure out quickly what we need to do in our chapters and for our chapters that is the right thing to do to improve retention and recruitment and make it a habit.

The Society Board has initiated some things that could be very exciting for our Society. They are all currently in the study phase with decisions to be made on many of them in the next three to six months. In summary, here is what we are studying and contemplating:

Global Strategy Task Force: We have ten affiliate organizations in other countries. Many of our members probably don't even know the extent of this global presence. Over the past several years there have been discussions about improving relationships with our affiliates and not just relying on meetings with them at our International Convention or occasional interface when a judge or staff member from the Society makes a trip to one of their conventions or a week of coaching. We feel that there are ways to get our organizations working closer together and that they can benefit from many things we do and we can certainly benefit from many things that they do. The Task Force will work to strengthen those relationships and educational opportunities.

Information Technology Policy Initiative: We have created a task force to develop a Society policy on the use of information technology. Our staff at headquarters is doing a great job with the limited resources t hat are provided to them. In many instances that places us on the backside of the wave of the future. And decisions regarding budgets and resources are not always made in a way that takes maximum advantage of the platform that a strong IT policy could provide. The results of this task force could change the way we conduct our business as a Society for years to come.

Mixed Harmony Affiliate: This task force is taking a hard look at what the Society can do to promote and encourage the formation, support and growth (including musical growth) of mixed harmony quartets. In the recent past there have been venues to allow such groups to perform – The Bolton Landing Festival and the Buckeye Invitational as two examples. But those opportunities have evaporated. And we have a lot of our members now singing in mixed harmony quartets. In many instances they are singing with their wives who may or may not be members of Sweet Adelines or Harmony Inc. There is little encouragement across the Society in providing coaching, educational opportunities and performance opportunities for these groups. If we want to create a larger umbrella that includes all people who love to sing barbershop, then certainly having an separate affiliate organization that would allow for these improvements would be beneficial to our own organization.

Foundations for a Lifetime of Harmony: Information has been provided to the board that indicates that there are nearly 2½ million home-schooled children in the United States and that curriculum for vocal music as part of their education is woefully limited and nearly non-existent. It was suggested that there is a great opportunity here for the Barbershop Harmony Society together with our sister organizations of Harmony, Inc. and Sweet Adelines International to step up and become the voice and source for vocal music education for these children and a major factor in the support of vocal music education in the United States. The Task Force was just recently formed and we anticipate some very exciting recommendations to come from the effort of this group. This is also a chance for the Society to do something that is external to our own members and our own organization and to have an impact in the lives of so many people in a selfless and altruistic action – in an area where I would daresay we have a huge amount of expertise.

These are exciting times for the Barbershop Harmony Society. The message is getting out loud and clear that membership is important. But the message is getting out also that we are an organization that can make a difference in people's lives, that can lift them up from their day to day worries, that can change our communities, and that can be the most relevant organization in our own community as a singing organization and as a community-minded organization.

We need to carry that message to every member of this Society. We need to carry that message back to our own chapters. We need to carry that message to everyone in our community with whom we come in contact. We need to believe that we are more than just a group of guys who enjoy singing and that we do matter.

Thanks for your efforts on behalf of all of us in the Barbershop Harmony Society.

Please review these updates with your teams/customers. All of the topics below are worthy of extra "color" but I would like to bring to your attention to a few observations.

### Youth Harmony Workshops / Harmony Explosion Camps



Fundamentally, these outreach programs are critical to executing on our Mission. Incorporating such programs within our communities provides for long-term success of our Society. Keep the workshops and camps fresh with new and exciting ideas and schedules. If your district/chapter hasn't tried one of these programs, the reward is tremendous for everyone involved!

### 6<sup>th</sup> Annual International Youth Barbershop Chorus Festival

Continue to get the word out! The benefits of the Festival are significant and can be life changing for everyone who attends. Don't miss out on a wonderful opportunity to participate (financially, in person, sponsorship, etc) in this exciting outreach



program. Many schools like to plan a year or two in advance, promote our 2014 Festival in Long Beach, CA, January 28<sup>th</sup> - February 2<sup>nd</sup>, 2014. Create the demand for one of the best male chorus festivals in the world!

### Harmony University



There are very few associations that actually produce a FUN, week long educational camp like HU. And this year was no exception. Seeing the generations of harmony displayed at the general sessions demonstrates the gift we have as a society. Having an entire chorus attend the camp substantiates the value of the University. George Davidson of Sound of the Rockies stated,

"...this was a transformational event for our guys...thank you for accommodating our needs and finding the right coaching and right HU balance." Consider having your entire chapter attend HU, July 28<sup>th</sup> – August 4<sup>th</sup>, 2013!



### International Convention

The Portland convention was fantastic with over 5700 people in attendance. Although a bit lower than last year's 5900 people (approx), several perennial larger choruses took the year off. Webcast subscriptions were also up this year by nearly 300 Gold Package (full-week subscribers), so if you watched at home, thank you for tuning in! All Society members and their families should make plans now to attend the 75<sup>th</sup> Anniversary Convention in Toronto next summer.

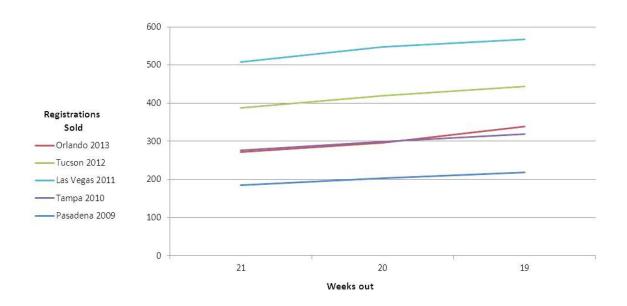

### Membership



Total Members on August 1, 2012 was 23,468. This compares to 24,172 members a year ago on that same date.

Operation Harold Hill launched on 1/1/12. 452 chapters are currently signed up to participate. Congratulations to the Pioneer District for having 100% of their chapters signed up! It's not too late for your chapter and its members to commit to membership growth in 2012.

### Harmony University



### For HU 2012 - Total student registrations: 447.

- 217 students attended Harmony College - including over 80 men from the Sound of the Rockies Chorus. SOR attended a modified coaching track to receive a week's worth of intensive coaching as well as participate in many of the classes offered in the HC curriculum.
- 28 students registered as Next Generation students in which they were able to take courses from any discipline.
- □ Directors College had 140 students
- □ 10 Music Educators in attendance

- 13 quartets that participated in the Quartet College, including two International caliber quartets.
- All of these students were taught / coached by 47 faculty members.
- 85 students received Harmony Foundation scholarships.
- By comparison, in 2011 we had 446 total students (154 HC, 171 DC, 82 QC, 11ME, and 31 NG) along with 53 faculty.



Highlights for HU 2012 included a keynote speech delivered by Marty Monson (can still be found online at <a href="http://www.youtube.com/watch?v=ABFtRXrZmhl">http://www.youtube.com/watch?v=ABFtRXrZmhl</a>), the introduction of our 75<sup>th</sup> anniversary theme song by Joe Liles, and countless hours of learning, singing, networking, socializing, and eating!

HU 2013 pre-registrations for 2012 attendees are already on sale (10 sold to date!). Early registration will open January 1<sup>st</sup> at the price of \$590. (Dates are July 28 – Aug 4, 2013)

### Harmony Explosion Camps



For 2012, 11 Harmony Explosion camps have been reported thus far, and 707 students and 25 teachers attended. Not all camps have occurred yet, and final numbers for 2012 won't be available until mid-October. Districts who have held camps thus far are JAD, CAR, SUN, MAD, DIX, EVG (2), SLD, PIO, and RMD.

By comparison, in 2011, our *total* numbers for the year were 13 camps reported, with 1155 students, 50 music educators, and a

total of \$69,100.00 was donated to these camps by the Harmony Foundation.

### Youth Harmony Workshops



For 2012, we have had 27 total workshops with 3555 students and 139 teachers in attendance. Districts hosting these workshops are CAR (1), CSD (6), DIX (1), FWD (3), LOL (8), MAD (4), NSC (1), PIO (1), RMD (2), SWD (1). More workshops will continue to be reported now that the academic year has started up again.

In 2011, 51 workshops were reported, which reached 7109 students, and 315 music educators. A total of \$39,500 was donated to sponsoring chapters in support of these workshops..

### Youth Chorus Festival



Registration for the 6<sup>th</sup> Annual International Youth Barbershop Chorus Festival is now open. Youth Choruses who are planning on participating must complete their online registration and submit a \$300.00 (refundable) deposit by

October 1 to guarantee a spot in the Festival. By November 1, all additional registration info must be submitted to Headquarters, or the choruses will be responsible for paying their Midwinter Registration fee (normally covered by Harmony Foundation).

### Chapter Achievement Program (CAP)

CAP is a program to recognize chapters (and encourage others to do so) for operating a healthy, balanced chapter life. Points are awarded based on several factors including chapter membership increase, membership programs delivered, chapter performances given, community involvement, fulfillment activities, etc.

Chapters had until June 1<sup>st</sup>, to fill out their survey. The 2011 version of the Chapter Achievement Program gathered 84 entries and the Top 10 are as follows in chart to the right.

By comparison, 2010 had 333 chapters participate / report and the top three were Asheville, NC, Mankato, MN, and Bloomington, IL.

Timely Updates to: Chapter and District officer listings, Chapter or District dues changes, members' personal records, death notices, due payments by Chapter Secretaries, IRS documents and state incorporation papers filed, ASCAP clearances obtained as needed.

### **Financial**

# Taxes & Financial Reviews

All US chapters should have filed a Form 990 (of some type depending on income) by May 15th. All chapters, both US and Canadian, should also have completed a financial review by that date. Updated filings with Secretaries of State are generally due from most corporations annually. While many chapters have complied with these requirements, some have not logged their compliance on the Financial Filings section of their chapter's eBiz page. This is very important as lists of noncompliant chapters, such as the one below, are pulled from the eBiz data, so updating it will prevent your being contacted unnecessarily.

Beginning in 2012, accidental medical insurance is included with your chapter's policy for the required general liability insurance. It is no longer a separate, optional charge. All chapters are covered.

### **Insurance Certificates**

Our general liability insurance certificates as well as the request form to get a third party listed as an additional insured are available on the Society's website:

<u>www.barbershop.org/document-center/category/68-insurance-documents.html</u>. The completed request form can be faxed to the insurance agency or the requested information can simply be e-mailed to them. Their contact details are on the form. They will provide you with the certificate you need.

### **ASCAP**

A chapter that performs in any show which is not exempt under U.S. Copyright law (see section 7.1 of 2012 Chapter Secretary Manual) must pay at least the minimum fee of \$230 for the year. A blanket agreement between ASCAP and the Society is in force. All Society chapters are covered by this agreement.

If at the end of a calendar year, a chapter has gross show revenue of less than \$51,111.11 they will pay the annual minimum ASCAP fee of \$230.

If the chapter's total annual gross show revenue is greater than \$51,111.11, see the 2012 Chapter Secretary Manual for details.

Chapters that do not perform in ANY show during a given year are not required to submit any payments. These chapters need to inform their District Secretary of this. The District Secretary should report this information to BHS at library@barbershop.org. Additional questions or clarification as to whether or not a chapter's performances would require payment should be directed to Janice Bane at library@barbershop.org.

We suggest that chapters send their yearly ASCAP payment to their District Secretary along with their first Show Clearance BMI/SESAC form (http://barbershop.org/document-center/category/71-show-clearance-and-legal-ascap-etc.html) and separate required payment, so that they may forward these payments to the Society upon receipt.

Chapters paying ASCAP fees should send a check payable to "Barbershop Harmony Society" along with the ASCAP Reporting Form, which can be found within the Chapter Secretary Manual or Chapter Secretary Manual Exhibits-2012(http://barbershop.org/document-center/category/69-chapter-secretary-document.html or by itself at http://barbershop.org/document-center/category/71-show-clearance-and-legal-ascap-etc.html BHS will collect all fees and make all payments to ASCAP. Chapters MUST NOT send any payment to ASCAP directly.

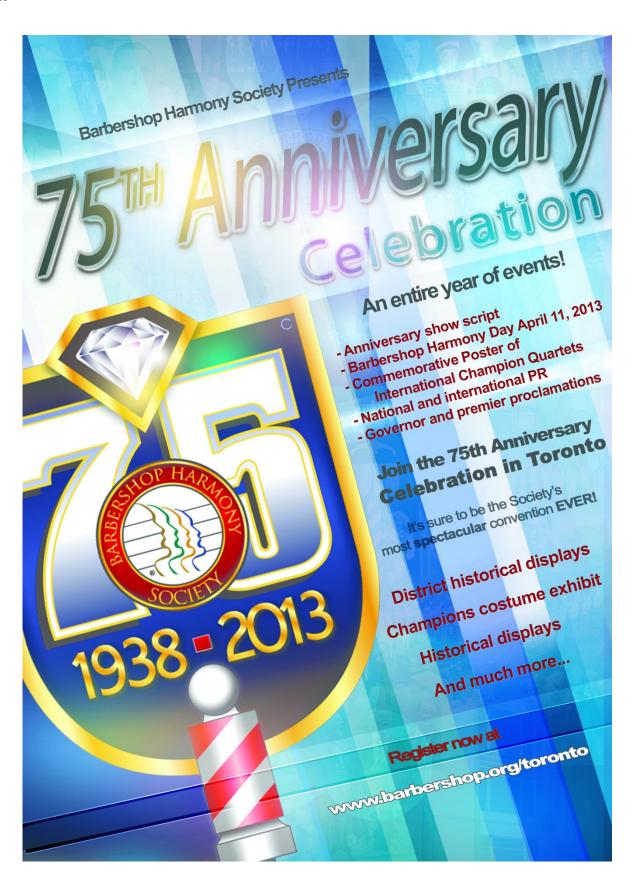

### **New Business:**

**Contest Draw.** The contest draw will be published after the International Convention.

Harmony Market Place at conventions: We will have a Barbershopper Shop in Mesa.

Motion to use Harmony Market Place profits for Youth Activities. Motion seconded.

#### Motion withdrawn.

Proceeds from the Harmony Market Place will be considered convention revenue and expense. Profits will be distributed in accordance with regular policy and procedure for handling convention finances.

**College Quartet Funding:** Russ Young. President Young expressed the opinion that the FWD should consider supporting the Youth Chorus Festival in Orlando, Florida as a sponsor of a chorus. The cost of a chorus sponsorship through the Harmony Foundation is \$10,000. The Foundation provides support to each participant in the Festival to pay for lodging and registration. Chorus sponsors will receive recognition at the convention in Orlando. No action taken.

#### **SOP Changes:**

Committee Report re: Show date conflicts. A lengthy discussion regarding the consequences of the current show clearance policy was held. The committee evaluated the possibility of changing the existing radiance of conflict from 50 miles to a much shorter radius. None of the alternatives were seen to resolve the issue of chapter conflicts. The best alternative was thought to be the elimination of restrictions on conflicts with other chapters completely. The result of removing such restrictions would put the responsibility of avoiding conflicts at the chapter level. Sometimes conflicts exist which could hurt smaller chapters, and sometimes conflicts may appear to be possible based on the proximity of show venues, but in fact do not. The board believed that in the interest of harmonious relationships among all FWD chapters, the resolution of conflicts should be at the chapter level. The board voted to recommend the removal of the proximity restriction to the HOD for action in the fall of 2012.

Motion to eliminate Sections 9.2 Sections B&C to eliminate restrictions on show date conflicts with other chapters. Motions carried.

President Young raised the issue of mistakes made at previous High School contests. Contest Administrator Chuck Leavitt explained the reason for the errors. The DRCJ (Ron Black) was asked to review the procedures for conducting the contest. Ron Black worked with Jim Halvorson (YIH Chairmen) and reported to the board on scoring for the High School contest.

### Motion to change the SOP regarding High School contests.

The changes will be included in the Fall Brochure for action by the HOD. Significant among them, "The High School Quartet Contest shall be administered under the auspices of the District Representative for Contest and Judging working with the District Chairman for Youth in Harmony. For this contest the procedures governing the operation, scoring, CA duties, evaluation and publication and announcement of results shall be identified in the District Spring Convention Regulations (document 2010-Spring Divisional Manual).

#### Motion carried.

President Young expressed concern that Society Judges at District and Division contest should be extended every courtesy and treated with sensitivity to their needs. The job of judges at contests requires long hours of travel and long hours of work at the contest and their efforts need to be appreciated.

#### **Convention Manuals:**

Russ asked for volunteers to review and revise the convention manual. Committee co chairs are Bill Rosica and Ron Black. Charge is to report back by the Fall board meeting.

### **Qualifying Scores:**

At each fall board meeting the DRCJ recommends the qualifying score for quartets and choruses to earn a spot in the next year's Fall Contest. DRCJ Black informed the board that his recommendation was ready at this time. These scores are used to partially complete the field, but choruses and quartets can still qualify with a lower score. The way it works: All competitors who make the qualifying score are invited to the contest and then the field is filled out to 25 from the remaining competitors. This ensures that there will not be a need for a quadruple judging panel and the attendant expense.

The current procedure was implemented about 12 years ago. Prior to that time the top five scoring competitors in each division earned a spot in the Fall contest. All remaining competitors were then ranked by score and the next ten were invited as "wild cards'. It was thought that this procedure unintentionally disparaged the accomplishment of those chapters who scored well enough to be invited but who had to wait until all division contests were complete.

Recommended scores are raised to:

Chorus: 63
Quartet: 68

#### Motion to approve recommendation. Motion carried.

#### Motion to increase fees removed from the table. Motion carried.

The discussion of the proposed fee increases for conventions and contest could now be continued. Division: increase \$5.00, District conventions \$5.00 (both early bird and late registrations.)

#### Motion to increase fees approved.

### Russ Young, President

As President of the Far Western District, it is my distinct pleasure to welcome you to the Fall Convention in my own hometown of Mesa. I know you are in for a real barnburner of a contest at one of the most beautiful facilities in Arizona. The convention team has worked meticulously to host a memorable event and I want to acknowledge their efforts. Thank you, team, for your hard work and for giving back to our hobby.

Your District leadership team has been working to continue programs for members. While attendance wasn't as high as usual, Harmony College West was a tremendous success. Attendees were thrilled at the opportunities available to them in the form of class offerings and the quality of instructors. I encourage members and associates to consider attending HCW next year, either as individuals, quartets, or bring your entire chorus. Either way, there's something for everyone.

Our District membership numbers continue to slide downward. Although not as critical as the Society as a whole, we have still lost about 3.5% since the beginning of the year. The following sections of the SOP was changed by a vote of the FWD Board subject to approval of the HOD at its meeting on October 12, 2012.

#### 9.2 Show Clearance Procedure

Granting of show clearance will be done only by the District Secretary, and the following rules will apply:

- 1. a) No show clearances are to be granted on District convention weekends, or Divisional Leadership Academy (see Art. XII para 12.3)Harmony Jubilee, Harmony College West or Chorus Director Seminar weekends.
- 2. b) A clearance may not be issued to a chapter within 50 miles of a chapter that has a previously cleared date.
- 3. c) Paragraph (b) may be waived with the consent of the chapter(s) that has received clearance.
- 4. d) Show clearance will not be granted on the same date as a chapter's own division quartet or chorus contest

#### Proposed change: Delete b) and c), and re-designate d) as b).

Allan Webb, on behalf of the Board:

Reason: Upon review by the Board, SOP Section 9.2 paragraphs b) and c) were judged to be bad legislation, due to the following factors:

- 1. They do not fundamentally solve the perceived problem they were intended to fix.
- 2. They can (and have) had an unintended consequence of being used punitively for emotional or political reasons.
- 3. Metropolitan geography, chapter distribution, and the limited number of weekends during the usual chapter show seasons make it effectively impossible to avoid show date conflicts.
- 4. Most chapters have their own perennial audiences who have ties to their chapter members, and another chapter having a show on the same date doesn't have an impact on their audience.
- 5. The remedy in the SOP (no advertising of a non-cleared show in District publications) has not been an effective deterrent.
- 6. The Board feels that the District shouldn't be in the business of arbitrating show dates between chapters, but only has an interest in show dates that conflict with District events, as outlined in a) and d).

During our discussion, the Board conducted exercises in changing the language of b) and c), such as using a smaller radius (as low as 15 miles) or using show venue as the location rather than chapter rehearsal venue. These experiments didn't fundamentally change the problems with this section, so we ultimately decided to recommend doing away with it altogether. Thus, it will be left to the Chapters to deal with each other (or not) on the subject of show date conflicts.

### 8.3.2.1.2. HIGH SCHOOL CONTESTS

Proposed by Ron Black and Jim Halvorson:

The FWD High School Quartet Contest shall be held during the Spring International Preliminary Quartet Contest weekend. The members of the High School quartet shall each be a currently enrolled junior high or high school student from any combination of high schools located within the boundaries of the Far Western District.

Each competing high school quartet member plus one coach or chaperone for each quartet shall receive an all events registration for the Spring Prelims at no charge, to encourage their exposure to a high level of barbershop quartet

singing. Furthermore, admission to the high school quartet contest session shall be free and open to the general public, with open (non-assigned) seating.

#### ADD:

The High School Quartet Contest shall be administered under the auspices of the District Representative for Contest and Judging working with the District Chairman for Youth in Harmony. For this contest the procedures governing the operation, scoring, CA duties, evaluation and publication and announcement of results shall be identified in the District Spring Convention Regulations.

Section 1.2 of the FWD Statement of Policy is amended to clarify that certain documents may be amended by direct action of the board and would not require HOD approval See italicized wording:

#### 1.2 Other Governance Documents

Other documents relating to the conduct of district affairs and referenced in this Statement of Policy include the Standard District Bylaws, Society Contest Rules, Society Statements of Policy, Society Operations Manual, WESTUNES Operations Manual and the FWD Directory. *In addition, the following documents, which may be amended from time to time by the BOD without ratification by the HOD, are referenced in this Statement of Policy:* 

- FWD Directory
- Score Based Plateau List (AAA, AA, A)
- District Youth Outreach Manual
- FWD Youth Medical/Parental Release Form
- Far Western District Youth Activity Code of Conduct for Adults,"
- FWD Convention Regulations.

The following documents, which can be amended only by action of the Society Board of Directors or the Society Executive Director, are referenced in this Statement of Policy:

- Society Contest Rules
- Society Statements of Policy
- Society Operations Manual

These documents are available either through the district website and/or the District Secretary's files. To the extent that the provisions of this District Statement of Policy conflict with the FWD Convention Regulations the rules set forth in this Statement of Policy shall prevail. All policy matters adopted by either the Board of Directors or the House of Delegates in the future will be incorporated herein. Amendments/revisions shall be made by additions to, or reprinting of, the affected page(s), and the reprinting of the table at the front of this document showing the following: date of the amendment, pages amended, reason for amendment, the authority for the change (HOD, FWD BOD etc.) and person responsible for making the change.

Society Governance and Bylaws Committee approval must be obtained for any amendment/revision to this Statement of Policy document. (See Section 17.03)

Notes to Financial Statements 8/31/2012

The budget for 2012 was prepared for the Summer Board Meeting in June of 2011. At that time I had very little experience as treasurer and we simply followed the outline used in previous years. As the year progressed I found ways to implement changes that I felt were appropriate to provide the Board with more complete information regarding the District's financial affairs. For example, I noticed that for activities like Harmony College West and Leadership Academy, the budget just showed the projected net cost to the district. Fees received and actual expenses were not tracked in the income statement so I began showing those items separately. Because of the changes in the way some of the income and expenses are now being tracked, there are cases where the numbers are not consistent with the budget. The budget for 2013 will allow us to see more of the details and that will be helpful for current reporting and future planning.

The following notes will provide further information about certain figures in the reports.

#### **PROFIT & LOSS**

#### **Income:**

500.00 – Based on the dues collected for the first 8 months of the year, it appears that our total dues collections for the year will be closer to \$50,000, which will be a significant increase over the budgeted amount.

506.00 – Other income - \$284.59

This is a reimbursement received from the BHS for ½ of our costs for Chapter Surveys

510.00 - Donations - \$1464.25 Harmony Foundation

\$2100.00 Northern California Youth Camp

\$ 246.00 Youth In Harmony Fund

We will be receiving more donations for the Youth Camp program

We receive checks twice a year from the Harmony Foundation under the Donor's Choice program. Last year the first payment was \$3458.90. Our second check will be received in October.

Note: We have to find a way to encourage Harmony Foundation Donors to include the FWD in their Donor's choice allocations

We made grants totaling \$1200 to the High Schools of the participants in the High School Quartet Contests and \$500 to a chapter that hosted a Youth Harmony Festival. These grants are made from the YIH Fund (shown on the Balance Sheet) and we must increase the donations to this Fund so we can continue to make these grants.

520.02 Harmony College West. We budgeted an expense of \$2500 for HWC for this year but because of low attendance our net cost was about \$5400. This is included in the Music & Performance budget and because the expenses in that budget have been low this year, it appears that we will have enough money to cover this shortfall. The President was advised of this shortfall and pursuant to the SOP he approved the expenses before they were paid.

#### **Expenses:**

703.00 EVP – The expenses for the EVP to attend the Midwinter and Summer Conventions were higher than budgeted but the President was advised and approved the

payments before they were made as required by the SOP

709.00 Chapter Support – We budgeted a net cost for Leadership Academy of \$5000 and we believe that will be adequate to cover the net costs for the Arizona and Southern California sessions

- 111.10 Prepaid Expenses These are venue deposits of \$1800 for the Spring 2013 convention and \$2000 for the Fall 2013 convention.
- 452.00 C&J reserve \$3750 This amount includes a 2012 contribution of \$1500 and the Fund will be used to send FWD judges to Category school in 2013.

In the Fall Westunes, I wrote about the Northwest Division statistics from the BHS mid-year membership data. As of July 1, the NW division had a 4.9% increase in membership year to date. The eight chapters that signed up for Operation Howard Hill collectively *increased* their membership by 30 members, but the five chapters that didn't sign up collectively *lost* 8 members.

So then I wondered what the membership statistics were for chapters participating in the division contest. Notice I didn't say compete because several chapters sang for evaluation only.
