Each Chapter gets one vote **if** they have a delegate present at the meeting. There is a credential at the end of this brochure to designate your delegate. You will:

- Vote on the proposed 2020 budget.
- Elect the 2020 Board of Directors.
- Vote on a SOP Change concerning the way we select the District High School Quartet Champions. – The proposed change is included in this document as an addendum. Here is a short explanation:

The High School Quartet Contest has been hosted at the Spring Convention requiring significant travel and commitment from some of the competitors. Spring is a busy time for students and the number of quartets has dropped dramatically. Moving the event to the local Division Contests will make it easier for student participation and encourage our Chapters' support for local youth quartets.

Note: Next year will be the 30th Anniversary of the Contest and it will be open to all High School and Middle School singers. Men, Women and Mixed quartets are welcome. This removes a perceived barrier to school participation.

I was honored to Emcee this year's Division Quartet Contests and the quality has never been higher. In addition to an extraordinary Quartet Contest, we will enjoy a

“too close to call” Chorus Contest that includes the 2017 International Champion - **Masters of Harmony** and celebrate our 2019 International Champion - **Westminster Chorus** - on the Show of Champions.

News Flash: In case you haven't heard, our **2020 Fall Convention at Sea** will be on the **Carnival Ship Imagination** departing from Long Beach (October 8-11). This will be an event to remember for the whole family. **Every Chorus that competes in the Spring will qualify to compete on the Cruise** so don't wait - book early so you don't miss the boat. Visit the table in the lobby for details.

On a personal note, this is my 6th and last time chairing a Convention and House of Delegates Meeting. My time as President has been amazing and I thank all FWD Barbershoppers and their families for the support and encouragement as we sailed on a voyage of transition. The Far Western District is stronger and more vital today and our future is bright. Please share your joy and passion for our “hobby”. It's too good to keep for ourselves.

What a busy Summer this has been. First and foremost, Donna Hisey and I have been keeping track of our registrants for the 2020 Fall Contest at Sea. As of this writing, we have 256 of the 500 blocked cabins spoken for, leaving 244. If 25 Choruses qualify and decide to go to contest that's about 750 men (30 men per chorus average). If another 25 quartets qualify, that's another 100 men for a total of 850 men. (I know, we have people in both contests) Doubling up we would need 425 cabins. You can see, we're going to run out of room if we don't get these rooms tied down. Remember, the public is booking rooms as well. Once we fill our quota of 500 rooms, Donna will ask for more, if there are any. Junior Suites and Grand Suites went fairly quickly. Brett Littlefield made a decision regarding the Fall Contest. Any chorus or quartet going to Divisional (and not getting DQ'ed) will be qualified. This will allow your Chorus or quartet to know that you qualified much earlier than in the past. So, if you are the least bit interested in experiencing a great time of singing and friendship aboard a Carnival Cruise Ship in 2020, Give Donna Hisey a call (1-714-801-7674) and reserve that cabin for you and your friends, significant other or quartet. A small deposit will hold your Cabin until well into next year. You can pay a little each month or the balance will be automatically taken from your credit card next year. Remember, we can't do this Cruising Contest without you.

I also attended the International Convention and Contest in Salt Lake City. My days were full, with the District President's Council Meeting, your Society Board Meetings, meetings with Perry White of Harmony Foundation, and the Society's Erin Harris. I also volunteered to work the Quartet Quarter Finals at the Sanctuary, scanning people into the venue. A lot of these activities were important to get a handle on as we will be hosting the International Convention next year in Los Angeles. Speaking of which, we will probably need many volunteers next year,

and our International Convention Chairman, Marlin Fors will be beginning to form committees soon.

And by now you know, because you're here, this year's Fall Convention and Contest is being held in Modesto. Our original Sacramento venue was undergoing a renovation and the hotels were set for another larger convention driving the cost of rooms to triple and even quadruple in price. For any chapter wishing to have their voice heard, please make sure you are attending the House of Delegates (HOD) meeting on Friday. We have been getting better with representation but have a way to go to have everyone's voice heard. "Everyone in Harmony" is a topic that comes to mind and the HOD will be the place to bring up your concerns. it, as I did and end up a leader of the District.

Hope to see you all sometime during the weekend.

- 1. Call to Order:** The meeting was called to order by President Craig Hughes at 9:03 AM.
- 2. The Old Songs** was led by Nick Papageorge.
- 3. The Invocation** was given by Chuck Roots.
- 4. Secretary Jim Maass called the roll.** The following board members were present.

Also in attendance was Russ Young, outgoing Music and Performance VP handing over the M & P VP duties to newly appointed Scott Suwabe.

Management Team members in attendance were Bryan Forbes, Events, David Melville, Marketing and Public Relations, Steve Salmon, Youth in Harmony, and Jeremy Loper, Membership.

- 5. Opening Remarks:** President Craig welcomed everyone to the meeting and introduced Scott Suwabe who he has appointed to fill the remaining term for Russ Young as VP Music and Performance. Russ will be assisting getting Scott up to speed.
- 6. Approval of the Agenda:** There were a few very minor adjustments to the agenda. It was approved by consensus.
- 7. Approval of the minutes BOD March 21, 2019.** Minutes were approved by consensus as presented.

8. Vice Presidents' Reports: (DVP full reports can be found on the FWD website.)

Division 1, Southwest. Brent Anderson mentioned a young quartet which has appeared out of nowhere and urged everyone to check them out. He also added that San Fernando Valley is excited about women with them and looking forward to the District convention this fall.

Division 2, Southeast. Nick Papageorge highlighted some of the items in his written report to the board.

Division 3, Northwest. Dick Whitten highlighted some of the items in his written report to the board.

Division 4, Northeast. Chuck Roots mentioned that Voice of California heading to SLC will be picking up Nevada tumbleweeds for stage props in their contest set. He also brought up the annual \$10 administrative fee from BHS for a dual member. There was some discussion.

Division 5, Arizona. Adam Kaufman reported that lots of good things going on. Eight chapters and 14 quartets were in the recent division contest which was well attended. They had a leadership dinner for chapter leaders which was very successful. He also mentioned that choruses need to be respectful in not scheduling shows on the same date.

Jim Maass brought up that he was aware of shows that are being performed without proper show clearance. There was discussion of the need to send a strong letter to the chapters not submitting appropriated show clearances with the district secretary. To not do this puts the chapter, district and the Society in jeopardy with BMI/ASCAP. Jim was directed to contact Janice Bane at BHS regarding this issue.

President Craig mentioned the new women's chorus forming in Arcata, CA as well as two potential ones in Arizona.

Contest and Judging. Brett Littlefield provided a spread sheet of the fall contest and those who will be competing. There was some discussion. It will be required that women and mixed quartets will need to perform two sets (two songs each) in order to win the contest. He's still working on the logistics for the flow for the contest. He brought up *Harmonia*, the new women's chorus chartered under Barbary Coast (Fog City). They chartered after the divisional contest this spring but have asked to sing/perform at Fall District contest for score and evaluation only. There was consensus that this would be OK but all women on stage must have a contest competitor registration and be a member of BHS/FWD.

Brett also mentioned that the Senior Quartet champs do not get plaques. They should and it was agreed by consensus to provide plaques at Division and District contests.

The Aloha Chapter is coming to district this fall. There was also some discussion about the afterglow at district convention and the fact that quartets were in evals during that time.

The FWD 2020 Cruise convention was discussed. After boarding the ship on Thursday afternoon, the quartet semi finals will be that evening, the chorus contest on Friday morning/afternoon with the quartet contest Friday evening. No contests on Saturday...Ensenada touring and everyone on their own. Show of Champs penciled in for Saturday night. There will be no evals on the ship.

The biggest challenge now is that competitors won't know if they qualify to go to district until they perform at their respective divisionals. It will be too late to get ship reservations at that point. After some discussion it was agreed by consensus that all quartets and choruses competing at their respective divisional (and not DSQ) will be invited to enter the FWD contest in the fall aboard the ship. This will keep the divisional contest solvent and allow competitors to plan NOW for performing on board the ship.

Music and Performance. Scott Suwabe mentioned he is excited to come onto the board for the remaining term. Russ Young talked briefly about the need to get chorus director's guild, harmony college west and leadership conferences back on track. David Melville brought up offering classes Friday afternoon at Fall Contest. There was some discussion.

Scott also brought up the Platoon program. His observation was that not many good singers are coming to participate. There was some discussion regarding the Platoon. Jim Maass brought up the issue that the platoon in Stockton (March) went out into the community (senior living/rest homes) to perform. While warming up he observed that they were not very good and asked if they should they be out in public performing.

9. District Management Team reports.

Membership. Jeremy Loper reported that there has been an increase in FWD membership.

Chorus Director Development. Scott Suwabe will be the Chorus Development Chair in 2020 (Rob Menaker is on the slate for VP M&P in 2020). Nick brought up the chorus directors guild and training classes for directors. Russ echoed the past success of the guild and the need to bring in high class directors to teach classes. Russ and Nick will support Scott in getting the Guild back up and running. Craig mentioned that Royce will continue to support the program as an instructor.

Events. Bryan Forbes is working on fees for hosting conventions and is looking at revenues tied to attendance in an effort to provide an incentive for a host chapter to get more attendance...get more money for hosting. There was some discussion as to how to approach this. President Craig asked is there a need to incentivize? Isn't the fee good enough now? For the present, the current fee structure will remain.

There was discussion at the Management Team meeting the night before and it was reported here regarding “**Convention Rotation**” which is being considered for the Fall convention. Fresno, Bakersfield, Fresno, Bakersfield, Mesa (repeat). This is because it has become very difficult to find performance venues and hotels which are reasonable in costs. These three cities provide an affordable place for district fall conventions.

Convention at Sea (2020). There was additional discussion regarding the cruise. There are lots of good cabins left. Also a question came up about “non barbershop talent” on board performing to give variety. Who the booked talent will be should be known six months out from sailing.

Marketing and Public Relations. David Melville brought up several house cleaning issues regarding plateaus needing updating on the website. Brett will assist if needed as women and mixed choruses come on board. He also mentioned marketing for the cruise contest 2020. He also shared some ideas for marketing conventions with things like tours, classes, golf tournaments etc. President Craig suggested to keep thinking outside the box. Brett mentioned increasing marketing to increase convention attendance.

Recommendations from David: Using convention videos to capture individual quartet/chorus pictures and no longer use an onsite photographer. He recommended taking down individual division Facebook pages and keep everything on the district FB page. He is shutting down the Forum as no one is using it.

David had an analysis of the hosting plans on the district server and the need to upgrade. He requested \$468 to upgrade current hosting plan to the “enhance” plan on a dedicated server. It was MSA to approve this request.

Marketing for the cruise...a half page advert in the Harmonizer will cost \$1275 for three issues. MSA by the board to approve this expenditure.

Youth in Harmony. Moving the HS Quartet contest to the spring divisional weekends was brought up. There was some discussion regarding putting the HSqtet contest into the draw for performing during the regular contest. Brett raised concern regarding the need to increase judging panel but he supports inclusion into the regular contest. After discussion it was agreed to move the HSqtet contest to the divisional. The winner for the district would be the quartet with the highest score. There would be plaques for the winners. There would be only one contest...mixed, boys and girls together. The winner would be invited to perform at the Fall district contest if they are available.

Financial Development.

Lloyd Steinkamp Endowment Fund. It is now up to \$90K and doing well. The District Endowment Fund is now at \$34036 up from the \$30K seed money.

10. Old Business.

Directors Guild. Discussed previously. See minute notes above.

11. New Business.

BHS Memorandum of Understanding (MOU) ..Bill reported that we have been tasked to sign and implement a MOU/MOC with the BHS and come up with specific activities. This all ties in with the Everyone in Harmony Mission. The focus on 2020 for a number of ideas we can approach BHS for assistance. It was cautioned that we not go beyond our means and keep the focus realistic. Russ Young brought up the issue that there is no “music staff” left at BHS like we use to have visiting chapters. When did this disappear, he asked? There was general discussion.

Three suggested activities to be entered on the 2020 MOU:

Improve skills of directors. Find and train potential directors. Reinvigorate the Chorus Director’s Guild and Seminars. Ask BHS for a grant to help develop it. Nick will help get the ball rolling. He has much info from past years to share. Measure success by the increase in attendance.

The Cruise. Ask BHS for assistance on the convention. BHS could provide and AIC quartet for the cruise. Also could assist in marketing. Measure success by increasing convention attendance.

High School Quartet Contest. Ask BHS for grant to assist in the program.

Awards Management. Russ Young has made a list of all trophies, pins etc. of what the FWD awards. It has become complex and needs management. President Craig will take a look at how to address this issue. Division VPs need to keep track of awards for each division. There was general discussion re additional awards, participation pins for example for mixed and women champs.

Financial Review. Rich Owen mentioned \$25K in the checking account not getting interest. He is looking into accounts where some interest is earned. He also brought up district support to the choruses and quartets going to International in SLS. He passed out checks to DVPs to be delivered to quartets and choruses.

Leadership Academy / Harmony College West. Looking for this to resume next Jan/Feb 2020 . There was general discussion. Loper and Suwabe to develop a proposal. This will be brought back to the board in October.

It was MSA to forward the slate to the HOD in October.

Various Issues:

Bill Rosica has met with Judy Steinkamp and Jill Steinkamp-Henderson and they are putting together a group called "Survivors." When a barbershop passes, the surviving spouse/partner is "cut out" so the desire is to keep them in the loop of what is going on so they are able to continue to be informed of what is going and can continue to participate.

Russ Young brought up the need for additional microphones for contests. Russ suggested it be put into next year's budget.

12. 2020 Budget Planning.

Rich Owen presented the budget worksheets for discussion and review. He and his committee have been working to put together this draft in an effort to make the board discussion productive.

There was discussion regarding the CJ category school and what would be the line numbers. Also microphones mentioned above. It was suggested that Masters, Westminster and Harbor Lights be approached to buy each mic (approximate \$300) as these three choruses use the current mics the most during a given year.

The board will review this at its June board meeting and set the fee schedule for next year.

Fall 2020 Convention at Sea

Bill Rosica

Bill introduced Donna Hisey from Expedia Travel who is organizing the cruise ship bookings. She mentioned that most the of ocean view cabins are gone with more than 100 reservations thus far. Her goal is to "take over the ship." 600 cabins have been set aside for the FWD Convention. She has set a goal to reach 200 cabins by the end of this weekend and 300 by the end of the convention in Sacramento in October. Bill encouraged everyone to get to word out. He said don't be that person who doesn't go and then which he did.

Financial Development

Roe Darnell

Roe talked about youth coming to his chapter as a result of the youth harmony camp. In addition he discussed the Harmony Foundation Donor Choice program and made a pitch to get more members signed up and to designate (up to 30%) to a chapter and the district. His is looking for the first FWD chapter to have 100% participation.

Spring Board Meeting Highlights

President Craig made brief remarks about the board meeting held the day before. We are the second largest district with more than 2000 members in five divisions. He reminded everyone that board meetings are open and that minutes are posted on the district website. The next board meeting will be a full day meeting in Fullerton, CA.

BHS Staff Update

Holly Kellar, Chief Marketing Officer, BHS, observed that there are four issues: Engaging youth education, Struggling chapters, Hobby Quartets and Non-competitors who want to sing. She sees it as all have to do with Everyone in Harmony. There need to be a way to find out how to engage people—men and women in singing. She is looking to welcoming not only women...but all to the barbershop hobby. She shared ideas about spreading the love of barbershop music. She is looking forward to the conversation. She also mentioned the scheduled “listening session” immediately following the HOD meeting.

Society Board Update

David Haedtler, Society Board Member reported in the Everyone in Harmony that change is hard to make whether it is good or bad. He indicated that 60-65% would like to keep things the same. The rest are mixed with women inclusion. He said it’s “all over the map.”

He discussed sex offenders list and the position of the society. It’s tough to deal with but the new rule, it is the right thing to do.

Show Clearance Information

You will find the BMI form on the FWD website. Go to the Media tab and open Show Clearance Forms. Then open to PDF document Application for Show Clearance BMI and SESAC License Form. Fill it out.

Where do you mail it? The information is right there too. Open the PDF Important Instructions for Preparation and Mailing. There is information on how to fill out the clearance form AND my mailing address where you will mail two copies (don't need a third as you will receive an approved form electronically via e mail). Sign the document and enclose the check in the appropriate amount. Mail to: Jim Maass, 1508 Brook Park Way, Roseville, CA 95747 . Done. It's that easy. Thanks

As we approach the Fall Convention in Modesto, I want to make sure that all choruses are in the best shape of their lives in order to have the most fun and enjoyable weekend. Please bother me with all your emails and questions regarding anything, anything at all, I am here to help to the best of my ability and figure things out with you.

If you are unsure of where to start with improving your chorus (be it attitude, musical ability, etc.), I advise you to keep an open mind and put some serious research in these areas:

- Please make sure to read the Harmonizer, there are great articles about different types of choruses you can become, as well as helpful advice regarding any sort of tricky problems, like attendance or community outreach (maybe leave previous ones in your chorus files to refer back to should something be interesting, that way your whole chorus has access to the information).
- Please bring in coaches for your chorus! No matter how big or how small, nothing can replace a true hands-on, in-person session by a coach (Board officers included, hint hint). Availability and timing are everyone's enemy, so please make sure to contact your preferred coaches early on to schedule a time that would work for everyone. Having access to Skype or some other form of realtime face-to-face over the internet helps out immensely with regards to getting help sooner. The District also helps with travel expenses, so please take advantage of that too!
- If you are looking for ways to improve singing, try looking up YouTube videos for Vocal Warm-ups. Not only do they demonstrate what you need to do and what it sounds like, but they also explain why warm-ups are so important. Our vocal health (and physical health) ties directly into our musical ability and overall enjoyment of barbershop, so please do not neglect your voices.
- Invite friends and family to hear your contest set and comment on it! Turn it into a fundraiser or a good old-fashioned potluck. We want our music to be accessible by our audiences, no matter how little their exposure to barbershop is. Getting an honest critique from those closest to you can change how you as a chorus should look performing, which can help you earn some crucial points at the contest.
- Rather than a contest set in your rehearsal hall, have more fundraisers and singouts in general! Maybe even interact with other barbershop choruses in your area should they exist. Share a fundraiser with the local elementary/middle/high school music programs, and perform on each other's shows. Exposure is our best resource (YouTube channel, anyone?), so share on social media as much as you can, who knows, your next chorus star may live just around your corner.

- Contact any of the District Board Officers with any questions you have. We want to help, and we want to make sure our District is growing the way that it needs to.

Please attend the HOD meeting in Modesto with your comments and questions, and please please PLEASE come find us at conventions or workshops and chat with us.

I am really looking forward to Modesto and meeting all of you who are as passionate if not more so than I am regarding the District and our wonderful hobby. Please stay cool in this summer heat, keep your throats hydrated, and I hope to see every one of you in Modesto.

This is my last official article as a member of the FWD Board of Directors; however, I may write another article in the future should the occasion move me to do so. As my last effort to help improve communications from the BHS in Nashville, and within our own district, I'd like to offer the following suggestion. My thought is not an original idea, but a rehash of something that has gone on since I joined the society in 1965. That idea is that Nashville (the society) is supposed to be a subsidiary of the 17 districts that make up the Barbershop Harmony Society. The current operational mode suggests otherwise; that the districts are the subsidiary organizations that work for/under the society.

Although we are told that everything done in Nashville has been discussed and vetted with the districts either by a survey or through communication from the President's Council who represent the districts, it has been my experience that several very important society decisions have been passed down from on high without the vetting that was implied.

There are ways to improve the communication and that is for you, as district and chapter leaders, to have more dialogue amongst yourselves and then pass those ideas and suggestions up to the society. How do we do this you ask? Attend House of Delegate meetings and District Board Meetings and listen to what is being disseminated on a regular basis. I did say pass information UP to the society and I did say LISTEN, which is 95% of communication. I realize that I'm preaching to the choir in some instances; however, attendance at the HOD meetings indicate that from 60 to 70% of the chapters aren't represented.

It's your organization and if you want to preserve what's been stated over the years get involved and be active with your chapter and district. If you don't participate in the chapter and district events it's very difficult to have a voice in what happens in your organization.
